## ESSEX COUNTY SOLID WASTE ADVISORY COUNCIL Meeting - Tuesday, November 25, 2011

The regularly scheduled meeting of the Essex County Solid Waste Advisory Council was held on Tuesday, November 25, 2010 at Essex County Environmental Center, 621 Eagle Rock Ave, Roseland, NJ. The meeting began at 1:00 pm.

#### PRESENT AT THE MEETING

The meeting began at 1:00 p.m. and adjourned at 2:30 p.m.

#### 1. CALL TO ORDER

Richard Fernicola-Chairperson called the Essex County Solid Waste Advisory Council meeting to order at 1:00 PM and thanked everyone for attending.

#### 2. OPEN PUBLIC MEETING STATEMENT

The meeting is in accordance with the Open Public Meeting Act. Publication of the meeting of the Essex County Solid Waste Advisory Council had previously been made and the public is invited to speak as noted on the agenda.

#### 3. APPROVAL OF MINUTES

The minutes of the November 25, 2010 meeting were moved by the representative from West Orange and second by the representative from East Orange and unanimously approved as submitted.

#### **Chairpersons Comments**

Richard Fernicola - Chairperson commented that if members agreed we will be combining both the SWAC and Recycling meetings into one meeting. The recycling agenda will be discussed during the committee reports. Mr. Fernicola reminded the committee they need to nominate persons for the Chair and Vice-Chair. The nominations will be done later in the meeting and final votes will be taken at the first meeting in January. Mr. Fernicola asked for a motion to move into Committee reports. The representative from West Orange moved the motion and it was second by the representative from East Orange.

#### **COMMITTEE REPORTS**

#### **Essex County Utilities Authority**

Nicholas Maddaloni advised the committee he brought copies of the SWAC by-laws for the members. If you need additional copies he hopes to have them put on the ECUA website. Mr. Maddaloni reminded the committee members they need to be re-nominated by the next reorganization meeting to be held in January. The nomination should also be confirmed by a town resolution. A discussion amongst member's ensued.

Mr. Maddaloni informed the committee members that New Jersey Meadowlands Commission/Keegan Landfill was the successful bidder for types 13, 13c 23 and 27.A discussion ensued amongst members. Mr. Maddaloni stated that tipping fees will be posted within the next several weeks. The representative from West Orange asked if 13 c was recycled at the Keegan landfill. Mr. Maddaloni responded it is not.

The committee was informed regarding the recent contract entered into with Advanced Recovery Inc. that now permits residents and municipalities to deliver e-waste directly to their facility. In addition the vender will still be conducting two events a year at the County DPW.

Mr. Maddaloni reminded the committee they need to adopt a resolution authorizing the ECUA to hold their HHW and E-Waste days.

Mr. Maddaloni spoke to the council regarding Clean Energy Fuels grant to convert refuse vehicles to natural gas. Open discussion ensued regarding Clean Energy Fuels.

- E-Waste Disposal Ban effective 1/1/11 Notify residents that garbage haulers cannot collect covered e-waste. (Additionally, e-waste should not be collected as or with Type 13 waste)
  - NJDEP issued letter to all haulers operating in New Jersey (available upon request from NJDEP and ECUA/BSG). According to NJDEP there are 11,000 haulers to which letters were sent;
  - Draft NJDEP E-waste regulations released on October 15 for public comments (available upon request from NJDEP and ECUA/BSG); 30-days of comments on the draft; then, another 60 days for comments on the revisions.

#### 5. County E-waste Recycling Plan:

- Semi-annual E-waste Collection Events will continue to be held for residents and municipalities;
