1. CALL TO ORDER

Nick Salese Sr. - Vice Chairperson called the Essex County Solid Waste Advisory Council meeting to order at 1:00 PM and thanked everyone for attending.

Covanta Energy

Covanta reported about their mattress shredding pilot program. Mattresses are separated from the waste on the tipping floor and placed into diesel powered shredder. Covanta is now exploring the costs associated with installing shredding machine. Covanta also discussed construction of the new “Bag Houses” and the new ferrous recovery system. Covanta also does not have any planned outages scheduled. **Discussion ensued amongst members.**
